NOTICE THAT TARIFFS WILL BE ALLOWED TO GO INTO EFFECT

Issue Date: May 31, 2019

On May 13, 2019, Confluence Rivers Utility Operating Company, Inc. (“Company”) filed proposed tariff sheets YW-2019-0207 and YS-2019-0208. The Company then filed substitute tariffs for YW-2019-0207 and YS-2019-0208 on May 16, 2019, and another substitute tariff for YS-2019-0208 on May 17, 2019. These tariff sheets were filed in response to the Commission’s February 14, 2019, *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity* (“Order”). This *Order* required the Company to “Submit new tariff sheets reflecting the maps and written descriptions of . . .the Auburn Lake Estates service area. . .as well as sheets reflecting the proposed rates for. . .the Auburn Lake Estates service area. . .with these or similar replacement tariff sheets to ultimately become a part of the adopted Roy-L water and sewer tariff documents.” Each of the tariff sheets bears an issue date of May 13, 2019, and a proposed effective date of June 12, 2019.

Staff filed a *Recommendation to Approve Tariff Sheets* (“Recommendation”) on May 20, 2019. The *Recommendation* stated that the tariffs comply with the Commission’s Order and recommended that the Commission approve them. The Commission received no other responses to the tariff filing or Staff’s *Recommendation*.

Given Staff’s recommendation and no opposition to the tariffs’ taking effect, the Commission will allow the Tariff sheets in Tariff No. YW-2019-0207 and YS-2019-0208 to take effect by operation of law on June 12, 2019.


