On February 26, 2019, the parties filed a Joint Status Report. That report stated that after the Staff of the Commission filed its Recommendation, other parties would have ten days to respond, after which the parties would file a Status Report.

Staff filed its Recommendation on May 24, 2019. On June 3, 2019, Great Southern Bank asked the Commission to bifurcate this proceeding to allow the application for Reflections Subdivision Master Association, Inc., and Reflections Condominium Owners Association, Inc., to proceed in a more expedited fashion than the application for the remaining service territories. Also on June 3, 2019, all of the other parties opposed Staff's Recommendation, and they each requested a hearing.

As contemplated in the February 26, 2019 Joint Status Report, the Commission will order a Status Report.

THE COMMISSION ORDERS THAT:

1. The parties will file a pleading as ordered above, or an alternative pleading, no later than June 24, 2019.

2. This order shall be effective when issued.


