On November 21, 2023, Union Electric Company d/b/a Ameren Missouri submitted a petition for a financing order, seeking authority to issue securitized utility tariff bonds for Energy Transition Costs and associated Financing Costs related to the early retirement of its Rush Island Energy Center. Sierra Club filed a timely application to intervene. Ten days have elapsed, and no party has objected to the application to intervene.<sup>1</sup> The application satisfies the requirements of Commission Rule 20 CSR 4240-2.075 and intervention will be granted.

- 1. Sierra Club's application to intervene is granted.
- 2. This order shall be effective when issued.
