On December 21, 2023, the Commission issued its *Order Granting Certificates* that incorrectly stated that “After this transfer, Chariton Valley Telephone will cease to exist...” in a sentence on page 3. The more accurate statement is, “After this transfer, Chariton Valley Telephone will cease to exist as a Telecommunications Company, as that term is defined in Section 386.020(52), RSMo (Supp. 2022).”

This Order Nunc Pro Tunc corrects that sentence in its prior *Order Granting Certificates*.

1. The sentence of page 3 of the Commission’s *Order Granting Certificates* issued on December 21, 2023, is corrected as stated in the body of this order.
