### ORDER DIRECTING RECOMMENDATION ON REVISED TARIFF

On December 21, 2023, the Commission issued an *Order Granting Certificate of Convenience and Necessity* (CCN) in this matter, to be effective on January 20, 2024. The order granted Spire Missouri, Inc., d/b/a Spire, a CCN to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Cass County, Missouri, as a further expansion of its existing certificated area.

Paragraph 2.a. of the order states, "Spire shall file an updated tariff sheet incorporating the additional certificated area granted by this CCN."

On December 21, 2023, Spire filed a revised tariff sheet, bearing an effective date of January 20, 2024, and assigned Tracking No. JG-2024-0092, purporting to comply with the terms of the Commission's December 21<sup>st</sup> order.

The Commission will ask its Staff to file a recommendation advising the Commission as to whether the submitted revised tariff sheet complies with the Commission's December 21st order.

### THE COMMISSION ORDERS THAT:

- 1. Staff shall file a recommendation regarding Spire's revised tariff sheet (Tracking No. JG-2024-0092) no later than January 4, 2024.
  - 2. This order shall be effective when issued.
