ORDER OPENING AN INVESTIGATION OF MISSOURI JURISDICTIONAL GENERATOR SELF-COMMITMENTS AND SELF-SCHEDULING

Both Midcontinent Independent System Operator (MISO) and Southwest Power Pool (SPP) operate day ahead energy markets designed to identify the supply of electric generation required to meet demand, and select demand-side and supply-side resources¹ for dispatch in a manner designed to minimize overall costs to the system while meeting reliability requirements. However, in some circumstances, a market participant may choose to self-commit a particular supply-side resource for dispatch and self-schedule that supply-side resource's output and accept whatever market price results rather than awaiting market commitment and dispatch by the Regional Transmission Organization (RTO).

The Commission is opening this case and directing its staff to begin an investigation into the self-commit and self-scheduling practices of Missouri's investor-

owned electric utilities in their respective RTO energy markets to determine if such practices inure to the benefit of their ratepayers. The Commission will also direct its Staff to file a report regarding the results of this investigation no later than August 16, 2019.

To accelerate staff review, the Commission requests that Missouri investor-owned electric utilities submit for each of its generation facilities on a monthly and annual basis over the last three years: (1) whether the utility has full control, minority partial ownership interest in such facility or has a power purchase interest in the capacity of such a resource; (2) the nameplate capacity; (3) the amount of net and gross energy generated; (4) amount of energy bid into the day ahead market and the amount that cleared; (5) amount of energy self-committed, self-scheduled and market selected; and (6) regarding the amount of energy self-committed, the difference between production costs and corresponding prevailing market prices. The Commission also directs each electric utility to outline the practices it employs with regard to resource bidding, and what strategy governs whether a resource is bid into the market or self-scheduled. Utilities and other stakeholders should consult Staff if further clarity as to these items is required. Responses should be submitted no later than June 28, 2019.

This file shall serve as a repository for documents and comments. Using this file, anyone with an interest in this matter may view documents and may submit any pertinent responsive comments or documents. Materials containing confidential or proprietary information will be treated and maintained in that manner, however, a public version shall also be provided for review. As this is not a contested case, anyone may file a comment without counsel and without *ex parte* constraints (arising from this matter). Intervention requests are not necessary to submit comments or view documents.

THE COMMISSION ORDERS THAT:

1. This case is established as a repository for documents and comments regarding Staff's investigation of the self-commit and self-scheduling activities of Missouri's investor-owned electric utilities.

2. The investor owned electric utilities are directed to provide the generation and self-commitment data, as described in the body of the order, no later than June 28, 2019 and be responsive to any additional staff requests for information.

3. Staff may also seek additional information or data from the investor owned electric utilities to aid in the investigation.

4. Any stakeholder may provide information by June 28 for consideration. Additionally, any stakeholder may review the submissions made by June 28 and respond to or provide additional related materials by July 8.

5. Staff shall file a report regarding its investigation no later than August 16, 2019. The staff report shall offer a summary of materials submitted, additional facts or observations as well as make any recommendations, if any.

6. Stakeholders may respond to the Staff report by August 30.

7. The Commission's data center shall provide a copy of this order to all Missouri electrical corporations, and to all intervening parties in the most recent rate cases for each electrical corporation.²

8. This order shall be effective when issued.
