**ORDER ESTABLISHING TIME FOR STAFF TO FILE A  
RECOMMENDATION**

On June 5, 2019, Union Electric Company d/b/a Ameren Missouri filed a request for variance from Commission rule 4 CSR 240-13.020(6) to allow it to implement tariff changes to permit its natural gas customers to choose a due date that would alter their billing cycles. Ameren Missouri filed a tariff along with its variance request to implement its plan. That tariff carries a July 5 effective date. Ameren Missouri also seeks a waiver of the Commission’s 60-day notice requirement to allow its request for variance to be filed immediately.

The Commission will direct its Staff to file a recommendation regarding Ameren Missouri’s request for variances and implementing tariff. The Commission will also establish a date for the filing of any other response.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file its recommendation regarding Union Electric Company d/b/a Ameren Missouri’s request for variance and implementing tariff no later than June 20, 2019.
2. Any other party wishing to respond to Union Electric Company d/b/a Ameren Missouri’s request for variance and implementing tariff shall do so no later than June 20, 2019.

3. This order shall be effective when issued.


