On December 17, 2018, the Staff of the Commission filed a recommendation and memorandum regarding its review of Spire Missouri, Inc. d/b/a Spire's 2016-2017 Actual Cost Adjustment for Spire's East and West service areas, in which Staff recommends an adjustment to reduce Spire's gas costs.
