On May 31, 2019, Carl Mills filed a letter requesting the Commission postpone the evidentiary hearing set to start June 24, 2019, for two months. In support of his request, Mr. Mills offers that he has contacted his state representative for “regulatory relief” as he believes the Commission lacks jurisdiction. The Commission ordered the other parties to respond to the letter no later than June 10, 2019. Both the Commission’s Staff and the Intervenors filed responses on June 5, 2019, recommending the Commission deny the request.

The Commission will deny the request to postpone the evidentiary hearing.

1. Mr. Mills’ request to postpone the evidentiary hearing is denied.
