ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION

On June 6, 2019, Missouri-American Water Company filed a *Tariff Revision* with an effective date of July 6, 2019, and a *Motion for Expedited Treatment* with the Missouri Public Service. Missouri-American Water Company requests expedited approval of a tariff in compliance with the Commission’s Report and Order issued in this case on June 5, such that it will be effective June 15, 2019, or as soon thereafter as is reasonable.

The Commission will direct its Staff to review and file a recommendation regarding Missouri-American Water Company’s request for expedited approval of a revised tariff.

THE COMMISSION ORDERS THAT:

1. No later than June 13, 2019, at 4:00 p.m., the Staff of the Commission shall file its recommendation regarding Missouri-American Water Company’s request for expedited approval of a revised tariff.

2. Any other entity wishing to comment on Missouri-American Water Company’s request for expedited approval of a revised tariff sheet shall do so no later than June 13, 2019, by 4:00 p.m.

3. This order shall be effective when issued.


