**ORDER REGARDING CHANGING MEMBERSHIP OF THE RELAY
MISSOURI ADVISORY COMMITTEE**

On June 3, 2019, the Staff of the Commission filed a motion asking the Commission to approve the appointment of new members to the Relay Missouri Advisory Committee. Staff asks the Commission to appoint Adonis Brown to fill the hearing position for a three-year term. Mr. Brown is the Executive Director of the Missouri Statewide Independent Living Council, Inc., responsible for training, technical assistance, and consultation related to the State Plan for Independent Living. Further, Staff asks that Marc Poston be recognized as an ex officio member of the board due to his position as Public Counsel.

The Commission will make the requested appointments.

So that the appointments will take effect as soon as possible, the Commission will give this order a ten-day effective date.

THE COMMISSION ORDERS THAT:

1. Adonis Brown is appointed to a three-year term on the Relay Missouri Advisory Committee for the hearing position.

2. Marc Poston is recognized as an ex officio member of the Relay Missouri Advisory Committee pursuant to his position as Public Counsel.

3. This order shall become effective on June 22, 2019.
