On June 14, 2019, KCP&L Greater Missouri Operations Company ("GMO") filed a Motion to Correct Tariff and Request for Expedited Treatment.<sup>1</sup> GMO states that the above-referenced tariffs need to be corrected, similarly to the tariff sheet the Commission corrected on June 5 when it approved Tariff No. YE-2019-0215. Approval of Tariff Nos. YE-2019-0221 and YE-2019-0222 will restore the tariffs that both GMO and the Commission intended to be in effect.

The Commission will give parties an opportunity to respond to GMO's motion.

**THE COMMISSION ORDERS THAT:**

1. Any objection to KCP&L Greater Missouri Operations Company's Motion to Correct Tariff and Request for Expedited Treatment shall be filed no later than June 19, 2019.
2. This order shall be effective when issued.


