### ORDER DIRECTING FILING

On November 27, 2018, S.K. & M. Water and Sewer Company ("SK&M") submitted a letter in accordance with the Commission's Staff Assisted Rate Case Procedure¹ seeking an annual water rate increase and an annual sewer increase. The Commission's Staff and SK&M filed *Notice of Non-Unanimous Disposition Agreement* on May 17, 2019. That filing included as an attachment the *Non-Unanimous Agreement Regarding Disposition of Small Utility Company Revenue Increase Request* ("Disposition"). Subsequently, on May 29, Staff and SK&M filed the Disposition as a stand-alone filing.

Additionally, SK&M filed new tariffs as captioned above. The Commission notes that the page numbers of JW-2019-0214 appear as "Original Sheet No. 1" for every page.<sup>2</sup>

  - a) Is the Non-Unanimous Agreement Regarding Disposition of Small Utility Company Revenue Increase Request identical in both filings, May 17, and May 29?
  - b) Which filed Disposition should the Commission approve, the May 17 filing or the May 29 filing?
- Please explain why each tariff sheet of JW-2019-0214 is labeled "Original Sheet No. 1", and whether the Commission can approve JW-2019-0214 in its present form.
