ORDER CONSOLIDATING FILES AND SETTING DEADLINE FOR STAFF RECOMMENDATION

On May 26, 2019, Missouri-American Water Company (the "Company") filed its *Application and Motion for Waivers* ("Application") in the above-captioned files. Additionally, on that date, the Company filed a *Motion to Consolidate* SA-2019-0365 with WA-2019-0364, with WA-2019-0364 to be the lead case. On May 29, 2019, the Commission issued notice, set June 12, 2019, as a deadline for intervention requests, and directed the Staff of the Missouri Public Service Commission ("Staff") to suggest a date by which it could file a recommendation on the *Application* and on the *Motion to Consolidate*. On June 13, 2019, the Staff filed its *Suggested Deadline for Recommendation and Nonopposition to Motion to Consolidate*. Therein, Staff agreed to the consolidation of file SA-2019-0365 with file WA-2019-0364, with the water case to be the lead case. Staff also suggested a deadline of August 16, 2019, to file its recommendation. No person has filed an application to intervene. The Commission will

issue an order consolidating the two mentioned files and set a deadline for Staff's recommendation.

The Commission will issue notice, set a deadline for intervention requests, and direct the filing of a recommendation by the Staff of the Commission.

THE COMMISSION ORDERS THAT:

- 1. SA-2019-0365 with WA-2019-0364 are consolidated with WA-2019-0364 to be the lead case.
- 2. No later than August 16, 2019, the Staff of the Missouri Public Service Commission shall file its recommendation on the *Application and Motion for Waivers* which Missouri-American Water Company has filed in each of the two consolidated files.
 - 3. This Order shall be effective when issued.
