**ORDER GRANTING MOTION FOR EXPEDITED TREATMENT AND  
APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER**

Issue Date: June 14, 2019

Effective Date: June 24, 2019

On February 20, 2019, Missouri-American Water Company's ("MAWC") submitted a request to change an Infrastructure System Replacement Surcharge ("ISRS"). On June 5, the Commission issued a *Report and Order* rejecting Tariff Number YW-2019-0160. In that order, the Commission authorized MAWC to file a new tariff reflecting the terms of the Order, namely that the recovery should not include net operating loss<sup>1</sup>. On June 6, MAWC filed a compliance tariff sheet (Tracking No. YW-2019-0214) designed to produce the appropriate revenue increase. The filed tariff sheet has an effective date of July 6.

Also on June 6, MAWC filed a *Motion for Expedited Treatment*, requesting the proposed tariff sheet to go into effect on June 15, or as soon thereafter as reasonable, rather than July 6. MAWC states that no harm will result from granting their motion, as their request is in conformity with the Commission order approving the ISRS.

On June 11, the Commission issued an order for an expedited recommendation from Staff of the Missouri Public Service Commission. Staff filed their recommendation for approval of the compliance tariff on June 12. Staff states it has no objections to the

request for expedited treatment. There were no objections to MAWC's compliance tariff or its request for expedited treatment.

Upon reviewing the pleadings, the Commission finds MAWC's tariff sheet complies with the Commission's June 5 order and will approve it. To allow this tariff to go into effect expeditiously, and as the *Motion for Expedited Treatment* was unopposed, the Commission finds good cause exists for the tariff to become effective in less than thirty days. For this reason, the Commission will approve the tariff becoming effective on June 24.

**THE COMMISSION ORDERS THAT:**

1. The following tariff filed on June 6, 2019, by Missouri-American Water Company, and assigned Tracking No. YW-2019-0219, is approved to become effective on June 24, 2019:
