#### ORDER PROVIDING NOTICE, ESTABLISHING INTERVENTION DEADLINE, AND DIRECTING RESPONSE

On June 14, 2019, Union Electric Company d/b/a Ameren Missouri filed an application with the Missouri Public Service Commission, requesting that the Commission grant it variances under Commission Rule 4 CSR 240-14.010(2) from certain requirements of the Commission Rule, 4 CSR 240-14.020(1) regarding prohibited promotional practices, and approval of revised Tariff Sheet No. 161.1 (YE-2019-0223). Ameren Missouri requests the variances to allow it to compete with Cuivre River Electric Cooperative, Inc., an unregulated entity, for business in a new subdivision.

Ameren Missouri also requests the Commission waive the 60 day notice provision of Commission Rule 4 CSR 240-4.017, and Ameren Missouri requests expedited treatment under Commission Rule 4 CSR 240-2.080(14) so that approval may occur no later than July 12, 2019.

The Commission will provide notice to other potential interested parties and the public, and will establish an intervention deadline. In addition, the Commission will establish a date for its Staff and other interested parties to offer recommendations regarding Ameren Missouri's request for variances.

#### THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to all parties to Ameren Missouri's most recent rate case, ER-2016-0179.

2. The Commission's Public Policy and Outreach office shall make notice of this order available to the media serving Ameren Missouri's service areas and to the members of the General Assembly representing Ameren Missouri's service areas.

3. Any proper person wishing to intervene in this matter shall file an application to do so no later than June 24, 2019.

4. The Staff of the Commission shall file a recommendation on the application and tariff sheet no later than June 24, 2019.

5. Any other party wishing to respond to Ameren Missouri's application, tariff, or Staff's recommendation shall do so no later than June 25, 2019.

6. This order shall be effective when issued.
