## ORDER GRANTING MOTION FOR FURTHER EXTENSION OF TIME AND SETTING TIME FOR RESPONSES

On February 12, 2019, Elm Hills Utility Operating Company, Inc. ("Elm Hills"), filed an application for a Certificate of Convenience and Necessity with the Public Service Commission ("Commission"). The Commission ordered the Staff of the Commission ("Staff") to file a recommendation no later than April 15, which was extended to May 20, following a joint motion from the parties. Subsequently, the parties jointly requested another extension for submission of Staff's recommendation to June 20, which was granted.

On June 6, the parties filed a *Joint Motion for Further Extension of Time to File Staff's Recommendation*. The parties requested more time for further discussion.

Commission Rule 4 CSR 240-2.080(13) states that parties have ten days to respond to pleadings unless otherwise ordered. Ten days have elapsed since filing of the joint motion for further extension of time. No party has objected to the request.

The Commission again appreciates the timely request for extension. The Commission finds that the joint request for further extension is reasonable and will grant it.

**THE COMMISSION ORDERS THAT:**

1. The *Joint Motion for Further Extension of Time to File Staff's Recommendation* filed jointly by Elm Hills Utility Operating Company, Inc., Staff, and the City of Sedalia on June 6, 2019, is granted.
2. Staff shall file its recommendation no later than July 22, 2019.
3. Any responses to Staff's recommendation shall be filed no later than August 1, 2019.
4. This order shall be effective when issued.
