On June 14, 2019, Ameren Missouri filed *Ameren Missouri's Motion to Strike Staff's Depreciation Study and Corresponding Testimony*. Ameren Missouri states that Staff's depreciation study and corresponding testimony should be stricken because Staff failed to include the information in its direct testimony as part of its case-in-chief, in violation of Commission Rule 4 CSR 240-2.130(7)(A).

Staff shall file a response addressing Ameren Missouri's motion. The response shall also include an accurate accounting of data requests regarding depreciation, when those data requests were due, and what correspondence occurred between the parties regarding those data requests.

### THE COMMISSION ORDERS THAT:

1. The Staff of the Public Service Commission shall file a response to Ameren Missouri's motion to strike no later than June 24, 2019.

2. This order shall be effective when issued.


