UTILICORP'S RESPONSE TO STAFF'S MOTION TO CONSOLIDATE

COMES NOW UtiliCorp United Inc. ("UtiliCorp"), d/b/a Missouri Public Service ("MPS"), by counsel, and for its response to the Motion to Consolidate Cases ("Motion") filed with the Missouri Public Service Commission ("Commission") in the captioned-matter by the Staff of the Missouri Public Service Commission ("Staff") on December 20, 2001, and respectfully states as follows:

- 1. UtiliCorp admits that Case No. ER-2001-672 is a pending proceeding before the Commission involving a tariff filing by UtiliCorp's MPS operating division. UtiliCorp denies each and every other allegation contained in paragraphs 1-18 of the Staff's Motion.
- 2. UtiliCorp submits that the Staff's Motion is premature in that the Commission has not granted the Staff authority to file an excess earnings complaint against MPS. The Staff requested such authority by a separate motion filed with the Commission on December 6, 2001 which separate motion was docketed as Case No. EC-2002-265. By its Notice of Complaint issued December 11, 2001, the Commission granted UtiliCorp thirty (30) days to satisfy or answer said motion.
- 3. On December 21, 2001, the Staff, without Commission authorization, filed its Excess Earnings Complaint against UtiliCorp United Inc. d/b/a Missouri Public Service in

said Case No. EC-2002-265. By its Notice of Complaint issued December 26, 2001, the Commission granted UtiliCorp thirty (30) days to satisfy or answer said complaint.

4. As will be explained in UtiliCorp's answers to be filed in accordance with the Commission's notices in Case No. EC-2002-265, "the Staff" has no standing to bring a complaint as it is not one of the enumerated parties listed in Section 386.390.1, RSMo, which is authorized to file a complaint nor is it one of the enumerated parties listed in Section 386.240, RSMo which can be authorized by the Commission to undertake certain acts. Alternatively, assuming that "the Staff" can be authorized by the Commission to file a complaint, as indicated the Commission has not expressly authorized the filing of the Excess Earnings Complaint by the Staff in Case No. EC-2002-265 pursuant to Section 386.240, RSMo, and in accordance with Op. Gen. Counsel Mo.P.S.C. No. 76-2, Pierce, 12-6-76.

WHEREFORE, in view of the foregoing, until UtiliCorp has filed its answers in response to the Commission's notices and the Commission has ruled as to whether or not any complaint may be brought or maintained by the Staff, the subject motion is premature and accordingly UtiliCorp requests that the Commission deny the relief sought by said Motion.
