On June 18, 2019, Summit Natural Gas of Missouri, Inc., filed an application to increase the amount of indebtedness secured by Summit's parent company's pledge of Summit's capital stock. The original request to secure up to \$225 million of indebtedness with a pledge of Summit's capital stock was approved by the Commission on March 23, 2019, in File No. GO-2019-0216. Summit now requests that amount be increased to an aggregate principal amount not to exceed \$310 million. Summit also requests a waiver of the 60-day case filing notice for good cause. The Commission will direct Staff to file a recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding the application, or a status report indicating when it expects to file a recommendation, no later than July 12, 2019.
