ORDER DIRECTING STAFF FILING

On April 15, 2019, Kansas City Power & Light Company (“KCP&L”) and KCP&L Greater Missouri Operations Company (“GMO”) filed the above-referenced pleadings. The Staff of the Commission found no deficiencies in the Reports. The Office of the Public Counsel, however, believes the Reports fail to comply with the pertinent Commission rules.

To assist the Commission in how to proceed, the Commission will order its Staff to respond to the following questions¹:

1. Does the formula used by KCPL/GMO to calculate Commission Rule 4 CSR 240-20.100(8)(A)(1)P RES “compliance costs” divided by total retail revenue dollars, accurately reflect the actual RES calendar year retail rate impact?
2. Please explain why it does or doesn't.
3. Does Staff agree or disagree that the RES Report is required to include all costs associate with the utility company's renewable generation? Please explain.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall answer the above-listed questions no later than June 28, 2019.
2. Any other party who wishes to respond shall do so no later than July 3, 2019.
