On April 15, 2019, Kansas City Power & Light Company ("KCP&L") and KCP&L

Greater Missouri Operations Company ("GMO") (together, "the Company") filed the

above-referenced pleadings. The Staff of the Commission found no deficiencies in the

Plans. The Office of the Public Counsel, however, believes the Reports fail to comply

with the pertinent Commission rules.

To assist the Commission in how to proceed, the Commission will order KCP&L

and GMO to respond to the following questions¹:

- 1. Does Staff believe that to be in compliance with the Renewable Energy Standard law or regulations, the wind PPAs excluded by KCPL because of "favorable economics" should be included in the RRI calculation?
- 2. If the answer is yes, when should the Commission address this issue?

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall answer the above-listed questions no later than June 28, 2019.

2. Any other party who wishes to respond shall do so no later than July 3, 2019.
