On April 15, 2019, Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO")(together, "the Company") filed the above-referenced pleadings. The Staff of the Commission found no deficiencies in the Plans. The Office of the Public Counsel, however, believes the Reports fail to comply with the pertinent Commission rules.

To assist the Commission in how to proceed, the Commission will order KCP&L and GMO to respond to the following questions¹:

1. Does Staff believe that to be in compliance with the Renewable Energy Standard Law in Chapter 393 or 4 CSR 240-20.100(8)(B), the 2018 wind additions included in GMO's 2018 IRP should be included in the RRI calculations?
2. If the answer is yes, when should the Commission address this issue?
3. Does Staff agree or disagree that the RES Plan is limited to including costs of renewables designated only to meet the RES requirements? Please explain.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall answer the above-listed questions no later than June 28, 2019.
2. Any other party who wishes to respond shall do so no later than July 3, 2019.
