The Commission opened this file as a working case to facilitate Staff's investigation of the self-commit and self-scheduling practices of Missouri's investor-owned electric utilities in their respective RTO energy markets. The Commission's order opening this file directed the investor-owned electric utilities to provide certain generation and self-commitment data to the Commission's Staff by June 28, 2019. The Commission allowed for further submissions and responses to be made by any stakeholder by July 8.

On June 21, Staff filed a request for comments in which it asked the Commission to order the investor-owned electric utilities, and invite other stakeholders, to answer certain questions as part of their June 28 or July 8 submissions and responses. The Commission will do so.

THE COMMISSION ORDERS THAT:

- 1. Union Electric Company d/b/a Ameren Missouri, Kansas City Power & Light Company, KCP&L Greater Missouri Operations Company, and The Empire District Electric Company shall answer the following questions as part of their June 28, 2019 responses:
- a. Please describe in detail reasons or scenarios that a utility may self-commit instead of bidding into a given market.

- b. Please provide the economic impact of the aforementioned scenarios, or indicate that the information is not available.
- 2. Any other stakeholder may respond to the questions set forth in ordered paragraph 1 in its June 28, 2019 comments, or in its July 8, 2019 response.
 - 3. This order shall be effective when issued.
