The Commission opened this case on February 27, 2019, at the request of its Staff, to facilitate Staff's investigation into the operations and conditions of Rex Deffenderfer Enterprises, Inc. d/b/a RDE Water Company (RDE). On June 21, 2019, Staff filed a Motion to Compel Discovery and Motion for Expedited Treatment, alleging that RDE has refused to cooperate with Staff's investigation in that it has failed to answer or otherwise respond to the data requests sent to the company by Staff. Staff asks the Commission to expedite its consideration of its motion to compel and to order RDE to respond to the data requests by June 28, 2019.

The Commission will not be able to expedite its consideration of Staff's motion to the extent requested by Staff, as the agenda for the Commission's June 24 agenda meeting has already been established and the Commission does not have another agenda meeting scheduled until July 10.¹ The Commission will, nevertheless, order RDE to expeditiously respond to Staff's motion to compel discovery

¹ Staff indicates it needs quick responses to its data requests so that it can complete its investigation and file a report by the August 30, 2019, deadline ordered by the Commission.

THE COMMISSION ORDERS THAT:

1. RDE Water Company shall respond to Staff's Motion to Compel Discovery and

Motion for Expedited Treatment no later than July 1, 2019.

2. This order shall be effective when issued.
