### STAFF'S RECOMMENDATION TO APPROVE TARIFF SHEET

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and for its *Staff Recommendation* respectfully states:

1. On December 1, 2023, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company"), filed one revised tariff sheet that takes effect on or before February 1, 2024. The revised tariff adjusts the Company's Missouri Energy Efficiency Investment Act ("MEEIA") Rider EEIC rates. The Company's filing included J. Neil Graser's Direct Testimony.

2. In its Order on December 4, 2023, the Commission ordered Staff to file a recommendation in this case no later than December 29, 2023.

3. Ameren Missouri requested that the Commission grant its request to adjust its Rider EEIC rates in Tariff No. JE-2024-0086. Ameren Missouri's proposed Rider EEIC rate will collect approximately \$95.5 million.<sup>1</sup> On average, the residential change under Rider EEIC will decrease by about 2.54% or \$0.09 per month per 1,000 kWh. Rider EEIC business rates will differ by class as a result of customer opt-outs, incentives, and projected costs that are further detailed in the Staff's Memorandum.

4. Staff conducted a review of the Company's tariff revisions<sup>2</sup> and accompanying testimony. Based on the limited review Staff could complete in the 30 day timeframe dictated by

20 CSR 4240-20.093(4)(B), Staff believes the Company complied with Section 393.1075, RSMo 2016, and applicable regulations in calculating the DSIM rate. Staff's recommendation for approval of the EEIC Rider rate changes in this case are solely based on the accuracy of Ameren Missouri's calculations and is not indicative of prudence. Staff recommends that the Commission issue an order approving the tariff sheet below, as filed on December 1, 2023, for service on and after February 1, 2024, the Company's requested effective date:

5. Attached hereto and incorporated herein by reference is Staff's Recommendation, in which Staff recommends the Commission approve the following tariff sheet. Staff verified that Ameren Missouri is not delinquent on any assessment and has filed its Annual Report.<sup>3</sup> Staff is not aware of any other matter before the Commission that affects or is affected by this filing.

**WHEREFORE**, Staff recommends the Commission issue an order approving the following proposed tariff sheet, to become effective by February 1, 2024, as requested by Ameren Missouri; and grant such other and further relief as is just in the circumstances.

### **AMEREN MISSOURI FILING**

On December 1, 2023, Ameren Missouri filed, with the Commission, one tariff sheet to be an effective on and after February 1, 2024. The tariff changes adjust the Missouri Energy Efficiency Investment Act ("MEEIA") Rider EEIC rates. Ameren Missouri's filing also included the Direct Testimony of J. Neil Graser. As filed, Ameren Missouri's overall Rider EEIC rate will collect approximately \$95.5 million.<sup>1</sup>

### BACKGROUND

The total proposed Rider EEIC rates are the sum of the remaining MEEIA 2016-18 Energy Efficiency Investment Rate ("EEIR") Components (MEEIA Cycle 2) and the currently effective MEEIA 2019-21 EEIR Components (MEEIA Cycle 3). Additionally, the total Rider EEIC rates also include a small portion of forecasted program costs and throughput disincentive for the extended MEEIA Cycle 3 programs approved in EO-2018-0211. The MEEIA Cycle 1 programs ended on December 31, 2015, and have been fully recovered.

Ameren Missouri's first MEEIA programs were approved in EO-2012-0142. Further, Ameren Missouri's second three-year MEEIA cycle was approved in EO-2015-0055 and Ameren Missouri's third three-year MEEIA cycle was approved in Case No. EO-2018-0211. Lastly, Ameren Missouri's MEEIA Cycle 3 was currently extended for a fifth year through the end of 2023 in Case No. EO-2023-0178. Below is a summary of the program costs, throughput disincentive, earnings opportunity and kWh saved for all three MEEIA cycles to date.

Ameren Missouri is projecting that the MEEIA Cycle 3 extension program costs, throughput disincentive, and earnings opportunity will be approximately \$98.4 million through 2024. Therefore, as shown in the table above, Ameren Missouri is projecting to have recovered from ratepayers through 2024 approximately \$1.2 billion for energy efficiency programs since MEEIA programs began in January 2013.

The Rider EEIC charge is reflected in a line item on the customer's bill labeled "Energy Efficiency Invest. Chg.". The proposed Rider EEIC rate changes are applicable to all kilowatt- hours ("kWh") of energy supplied to customers served by Ameren Missouri under service classifications rate schedules 1(M) - Residential Service; 2(M) - Small General Service; 3(M) - Large General Service; 4(M) - Small Primary Service; 11(M) - Large Primary Service; and 12(M) - Large Transmission Service, excluding kWh of energy supplied to "opt-out" customers.

### **STAFF REVIEW**

The table below provides the current Rider EEIC rate and the Company's proposed rate.

All else being equal, the average residential change pursuant to Rider EEIC will decrease by approximately 2.54% or \$0.09 per month per 1,000 kWh. A residential customer, using 1,000 kWh will have a total EEIC charge of approximately \$3.57 month or \$42.86 annually. Rider EEIC business rates per class vary due to projected costs, incentives, and customer opt outs per class of customer. The Small General Service rate will increase by approximately 7.78% or \$0.27 per month per 1,000 kWh; the Large General Service rate will decrease by approximately 16.34% or \$0.75 per month per 1,000 kWh; the Small Primary Service rate will decrease by approximately 14.67% or \$0.59 per month per 1,000 kWh; the Large Primary Service rate will decrease by approximately 8.82% or \$0.34 per month per 1,000 kWh. The monthly and annual average rate charge per 1,000 kWh are also given in the chart below for each rate class.
