NOTICE REGARDING FISCAL NOTE REVIEW AND CLOSING FILE

Issue Date: July 1, 2019

Section 536.200.2, RSMo 2016, requires the Commission to review the fiscal representations it made regarding its 2017 revision of 4 CSR 240-2.135, the Commission's confidential information rule. If, at the end of the first full fiscal year after the implementation of the rule, the Commission finds that the cost to all affected entities has exceeded by ten percent or more the estimated cost in the fiscal note, or has exceeded five hundred dollars if an affidavit was filed stating the rule amendment would cost less than five hundred dollars, it is required publish a description of the actual cost of complying with the rule in the Missouri Register within ninety days after the end of the first full fiscal year. The rule amendment in this case became effective on July 30, 2017. The first full fiscal year after its effective date began on July 1, 2018, and ended on June 30, 2019.

The proposed amendment of the rule contained an affidavit stating that it would cost less than five hundred dollars. The Commission invited interested stakeholders to submit comments about whether the estimated costs to comply with the rule amendment has proved to be accurate. No comments have been submitted.

Based on its review of the fiscal representations made regarding the revision of 4 CSR 240-2.135, the Commission concludes that no fiscal estimate change need be filed with the Secretary of State. This file may be closed.
