STAFF RECOMMENDATION TO APPROVE TARIFF SHEETS

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through the undersigned counsel, and files its *Staff Recommendation to Approve Tariff Sheets* and states as follows:

1. On December 21, 2023, Missouri-American Water Company (“MAWC”) filed tariff sheets in Tariff Tracking Nos. JW-2024-0093 and JS-2024-0094 in an effort to comply with the Commission’s December 21, 2023 *Order Approving Water and Sewer Infrastructure Rate Adjustments*.

2. The tariff sheet filed by MAWC bears an issue date of December 21, 2023, and a requested effective date of January 20, 2024.

3. Staff reviewed the tariff sheets filed in Tariff Tracking Nos. JW-2024-0093 and JS-2024-0094 and confirmed that the tariff sheets are consistent with the Commission’s December 21, 2023 *Order*.

4. Staff has reviewed and recommends the Commission approve or allow the following to go into effect for service:

6th Revised Sheet No. RT 11.1, Cancelling 5th Revised Sheet No. RT 11.1

6th Revised Sheet No. RT 11.2, Cancelling 5th Revised Sheet No. RT 11.2

WHEREFORE, Staff recommends the Commission either issue an order approving the tariff sheets filed in this matter in Tariff Tracking Nos. JW-2024-0093 and JS-2024-0094, or allow the same tariff sheets to go into effect by operation of law.


