## NOTICE OF EXPIRATION OF VIDEO SERVICE AUTHORITY

Issue Date: January 3, 2024

On January 2, 2024, Le-Ru Long Distance Company notified the Commission that it has no customers, has ceased to provide video service, and seeks to cancel its Video Service Authority. The Commission granted Le-Ru Long Distance Company authority in File No. KA-2008-0064, to serve Newton County and McDonald County.

Under Section 67.2685, RSMo 2016, Le-Ru Long Distance Company's service authorization expired upon notice to the Commission that it will cease to provide video service under that authorization. The Commission acknowledges receipt of notice by Le-Ru Long Distance Company that it has ceased to provide video service. The authorization has expired by operation of law and no further action by the Commission is required. This file may be closed.
