**ORDER EXTENDING DEADLINE FOR STAFF RECOMMENDATION  
AND SETTING DEADLINE TO RESPOND TO CONSOLIDATION**

On November 7, 2023, Trevor King filed an application with the Commission requesting a change of electric supplier from Eversource Missouri West, Inc. d/b/a Eversource Missouri West (EMW) to Osage Valley Electric Cooperative (“Osage Valley”).

On December 13, 2023, both EMW and Osage Valley filed their responses to the application. On January 2, 2024, the Staff of the Commission (Staff) filed its *Report and Request for Like Treatment* requesting additional time to file its recommendation on Mr. King’s application. Staff also pointed out that the change of electric supplier applications of Mr. King, Matthew Gibreal (File No. EO-2024-0166), and Tyler Watts (File No. EO-2024-0181) are closely related. Staff suggested that the Commission set the deadline for Staff’s recommendation in all three files to the same date and that the Commission consider consolidating the files.

The Commission finds both requests reasonable. The Commission will grant Staff additional time to file its recommendation and set a deadline for the parties to file any objections to consolidating the three cases.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file its recommendation regarding Mr. King's application no later than February 16, 2024.
2. Any party objecting to consolidating this case with the change of electrical supplier cases of Matthew Gibreal (File No. EO-2024-0166) and Tyler Watts (File No. EO-2024-0181) shall file a response to this order no later than January 16, 2024.
3. This order is effective when issued.
