**ORDER EXTENDING DEADLINE FOR STAFF RECOMMENDATION
AND SETTING DEADLINE TO RESPOND TO CONSOLIDATION**

On December 1, 2023, Tyler Watts filed an application with the Commission requesting a change of electric supplier from Evergy Missouri West, Inc. d/b/a Evergy Missouri West (EMW) to Osage Valley Electric Cooperative (“Osage Valley”).

On January 2, 2024, EMW filed its response to the application; Osage Valley has yet to file a response. In an order issued on December 1, 2023, the Commission ordered its Staff to file a recommendation on Mr. Watts’ application, or a report stating when it expects to file a recommendation, no later than January 17, 2024.

The Commission also has pending change of electric supplier applications from Matthew Gibreal (File No. EO-2024-0166) and Trevor King (File No. EO-2024-0161). In those cases, Staff has pointed out that the three change of electric supplier applications are closely related. Staff suggested that the Commission set the deadline for Staff’s recommendation in all three files to the same date and that the Commission consider consolidating the files.

The Commission will grant Staff additional time to file its recommendation in this case so that the deadline date for Staff’s recommendation coincides with the deadline

date in the other two files. The Commission will also set a deadline for the parties to file any objections to consolidating the three cases.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding Mr. Watts' application no later than February 16, 2024.
2. Any party objecting to consolidating this case with the change of electrical supplier cases of Matthew Gibreal (File No. EO-2024-0166) and Trevor King (File No. EO-2024-0161) shall file a response to this order no later than January 16, 2024.
3. This order is effective when issued.
