Comes now UtiliCorp United Inc. ("UtiliCorp") d/b/a Missouri Public Service ("MPS"), by counsel, and, suggests to the Missouri Public Service Commission ("Commission") that the Commission Staff's ("Staff") Motion to Compel is now moot:

- 1. On or about January 15, 2002, the Staff filed its Motion for a Commission Order Compelling Missouri Public Service, a Division of UtiliCorp United Inc. to Answer Staff's Data Requests Nos. 570 and 580, and for Expedited Treatment. This motion requested that the Commission issue an order by January 17, 2002, compelling responses by January 18, 2002.
- 2. On January 16, 2002, UtiliCorp provided to Staff representatives hard copies of the agreements requested by Data Request 570 (for which UtiliCorp had previously referred the Staff to the FERC web site), as well as answers to the remainder of Data Request 570. January 17, 2002, UtiliCorp provided additional information in response to Data Request 580 to a Staff representative and sent copies of both the responses to counsel for Staff.
- 3. Accordingly, UtiliCorp believes that the subject data requests have been satisfied and that the Staff's Motion to Compel is now moot.



WHEREFORE, UtiliCorp respectfully requests that the Commission issue its order denying the Staff's Motion to Compel because it is now moot and granting such further relief as the Commission deems appropriate.
