AFFIDAVIT OF CARL HARDWICK

COMES NOW Carl Hardwick, of lawful age, sound of mind and being first duly sworn, deposes and states:

- 1. My name is Carl Hardwick. I am a Customer Support Representative for Aristotle Unified Communications, L.L.C.
- My primary responsibility is to handle Tier 1 technical support calls; however, occasionally I also take calls from potential customers who are seeking broadband service with Aristotle.
- 3. According to phone logs, on the afternoon of December 18, 2023, I received a call from someone with telephone number (573) 434-3460. I have subsequently been informed that this number belongs to Kari Salsman and that the address associated with that number is in Eldon, Missouri. The call lasted 2 minutes and 15 seconds.
- 4. Aristotle does have service in portions of Southern Missouri, but we do not serve Eldon.
- 5. While I do not remember this specific call, I follow a process whenever I receive a call requesting service. The first step of this process is to consult Aristotle's coverage map. I have a map of the areas Aristotle serves in Missouri, which map includes the CAF II locations in Ozark, Oregon and Howell counties. I reference this map whenever I receive a call from someone with a Missouri address, and I would have consulted this map to determine whether Ms. Salsman's address was within our coverage area.
- 6. Once I determined that the address was outside the service area, I would have said the following in accordance with our script: "We are not serving that area right now, but we are always expanding. May I save your information so we can call you when we can serve you?"

- 7. I use this script whenever the address is outside our service area, and I try never to deviate.
- 8. I am aware that Aristotle has service to specific locations in Missouri, and since becoming aware of that fact I have never told a potential customer that we do not serve Missouri.
- 9. There is no record of this call in our Customer Support Management software system, VISP. From this, I conclude that Ms. Salsman declined to give me her contact information, because had she done so, I would have logged that information into VISP.
- 10. I hereby swear and affirm that my statements contained herein are true and correct to the best of my knowledge and belief.
