On July 27, 2023, the Commission ordered the parties to file a status report no later than January 2, 2024. The Commission's Staff timely filed a status report on behalf of the parties. This proceeding is currently stayed while the parties await the outcome of File No. AW-2018-0394, which may change the Affiliate Transactions Rule affecting this proceeding. The parties state that this CAM proceeding would be greatly impacted by a new Affiliate Transaction Rule. Accordingly, the Commission will continue the stay and order the parties to file another status report.

1. The parties shall file a status report no later than July 30, 2024.
2. This order is effective when issued.
