On October 13, 2023,<sup>1</sup> Liberty Utilities (Missouri Water) LLC d/b/a Liberty submitted an application requesting authorization to issue long-term debt in the amount up to \$30 million.

On December 21, the Staff of the Commission (Staff) filed its Recommendation which included eight proposed conditions. The Commission will direct Liberty to respond to Staff's proposed conditions.

### THE COMMISSION ORDERS THAT:

1. No later than January 9, 2024, Liberty shall file a response as set forth in the body of this order.
2. This order shall be effective when issued.
