ORDER APPROVING COMPLIANCE TARIFF SHEET

Issue Date: January 4, 2024

Effective Date: January 20, 2024

On December 21, 2023, the Commission issued an *Order Granting Certificate of Convenience and Necessity* (Order) in this matter, to be effective on January 20, 2024. The Order granted Spire Missouri Inc. d/b/a Spire a certificate of convenience and necessity (CCN) to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Cass County, Missouri, as a further expansion of its existing certificated area.

The Commission granted the CCN subject to certain conditions, including that Spire file an updated tariff sheet incorporating the additional certificated area granted by the CCN.

On December 21, 2023, Spire filed a tariff sheet purporting to be in compliance with the Commission’s Order. That tariff sheet was assigned Tracking No. JG-2024-0092 and had a proposed effective date of January 20, 2024.

At the Commission’s request, on January 2, 2024, the Staff of the Commission reviewed Spire’s tariff sheet and filed its recommendation that the Commission approve the tariff sheet or allow it to go into effect by operation of law. Upon reviewing the

pleadings, the Commission finds Spire’s proposed tariff sheet complies with the Commission’s Order and will approve it. To enable the tariff sheet to become effective on the date requested by Spire, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheet filed on December 21, 2023, and assigned Tracking No. JG-2024-0092 is approved to become effective January 20, 2024. The approved tariff sheet is as follows:

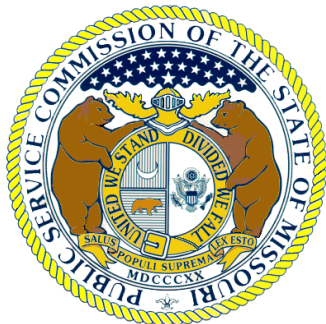
