RESPONSE OF MARK EDWARD KREBS

COMES NOW Mark Edward Krebs (Krebs) and for his Response to Ameren Missouri's Opposition to his Motion to Intervene, states as follows:

I. In its Response, Ameren Missouri argues that Krebs should not be permitted to intervene because he has an interest that is no different than the general public. Ameren Missouri further asserts the this means the Commission must deny intervention unless it finds that such intervention would be in the public interest which Ameren Missouri argues, without explanation, it would not be.

2. Contrary to Ameren Missouri assertion, Krebs has an interest that is markedly different from the general public. He has for decades argued against efforts to obliterate natural gas and coal as a fuel sources for energy production, pointing to the reliability and cost issues raised be a too heavy reliance on renewables. (See Exhibit A for his list of publications in which his comments have appeared). In doing so, Krebs is really no different than those environmental groups, like the Sierra Club and the Environmental Defense Fund, except for the relatively unlimited financial resources to assert their anti-natural gas and anti-coal positions in any legal or regulatory arena where such issues can be raised, and for the fact that Krebs actually lives in Ameren Missouri's service territory.

3. In this instance, Ameren Missouri's ratepayers may be forced to spend upwards of \$7 Billion (or more) on renewables in order to avoid approximately \$1 Billion in scrubbers, and to face the inherent reliability concerns associated with a permanent scrapping of its Rush Island Energy Center in favor of unreliable renewables plus batteries. Krebs respectfully suggests that the stakes are too high and too permanent for the issues to be decided without any countervailing input, which is exactly what Mr. Krebs would bring to this proceeding.
