MOTION TO RESCHEDULE PREHEARING CONFERENCE and EVIDENTIARY HEARING

COME NOW Timothy and Denise Allegri, Complainants, and for their *Motion to Reschedule Prehearing Conference and Evidentiary Hearing*, state as follows:

- 1. On December 21, 2023, the Missouri Public Service Commission ("PSC") issued its *Order Establishing Procedural Schedule* ("Order").
- 2. Complainants and Evergy Missouri West, Inc. ("Evergy") are currently engaging in settlement discussions, seeking to resolve issues at hand in this case through a mediation agreed to by both parties and tentatively scheduled for February 15, 2024.
- 3. There is a *WebEx Prehearing Conference* scheduled for January 18, 2024 and an *Evidentiary Hearing* scheduled for January 23-25, 2024. Due to the timeline of these events, Complainants request the PSC reschedule both hearings to the week of February 26, 2024 to allow for the mediation to take place and, if necessary, the preparation of any proposed settlement documents prior to continuing with the PSC hearings or, if a settlement is reached, the dismissal of the complaints. In addition, the resolution of location of the Evidentiary Hearing will need to be made prior to rescheduling, per the *Motion to Correct Status of the Complaint Be Changed* filed on January 2, 2024.

4. The *Procedural Schedule* deadline for *Discovery* and *Party Position Statements* is

January 8, 2024, which will remain effective.

5. There are pending *Motions* (EFIS Docket Items #82, #84 and #85) which still need to

be considered and orders made.

6. Complainants have apprised Respondent of this and Evergy supports the rescheduling

of the hearing to the week of February 26.

MOTION FOR EXPEDITED TREATMENT

Pursuant to 20 CSR 4242.2.080(14) a party may move for expedited treatment of any

pleading by including the words "Motion for Expedited Treatment" in the title and setting out the

day by which the party asks the Commission to act, the harm or benefit resulting from inaction
