On December 13, 2023, the Commission approved the above-referenced application. On January 5, 2024, Confluence Rivers Utility Operating Company, Inc. filed tariffs to implement the Commission's order. The tariffs bear an effective date of February 4, 2024. However, Confluence asks for expedited treatment so that the tariffs may go into effect no later than January 29, 2024.

The Commission will order its Staff to file a Recommendation.
