On August 25, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed applications seeking, among other things, authority for Confluence to acquire and operate the water and sewer systems of Lake Sherwood Estates.¹ Both Confluence and the Staff of the Commission request the Commission to extend Staff's deadline to respond to the application to February 26, 2024.
