## INVITATION TO FILE COMMENTS REGARDING COSTS OF COMPLIANCE

Section 536.200.2, RSMo 2016 requires the Commission to review the fiscal note that is attached to its 2017 revision of various rules relating to manufactured housing at the end of the first full fiscal year following the implementation of the rules.<sup>1</sup> As part of that review, the Commission's Staff filed a motion on July 1, 2019, asking the Commission to invite interested stakeholders to offer comments about whether the estimated costs to comply with the rules set out in the fiscal notes have proved to be accurate. The Commission will do so.

- Comments regarding the actual cost of compliance shall be filed with the Commission by July 19, 2019.
