**NOTICE THAT FILE HAS CLOSED, AND NOTICE OF NEW FILE  
NUMBER**

Issue Date: July 9, 2019

On January 4, 2019, Lincoln County Water and Sewer, LLC (Lincoln County) filed notice, pursuant to Commission Rule 4 CSR 240-4.017(1), indicating its intent to file an application with the Missouri Public Service Commission for a Certificate of Convenience and Necessity for a water and sewer system. The Commission's rule provides that if the application is not filed within 180 days, the noticed case shall close.

More than 180 days have passed since Lincoln County filed its notice and by terms of the regulation, File No. SA-2019-0202 has closed. On July 3, 2019, the 180<sup>th</sup> day after the notice was filed, Lincoln County filed a notice in SA-2019-0202 indicating its continued intention to file an application. The Commission has treated that filing as a new notice of intended case filing and assigned it a new file number, SA-2020-0004. When Lincoln County files its application it should do so in that new file.
