## ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On May 22, 2019, 188 North Summit, LLC, filed an application asking the Commission to cancel its certificates of convenience and necessity to provide water and sewer service granted in File Nos. SM-2018-0017 and WM-2018-0018. 188 North Summit, LLC, also requests “decertification” so that it is clear that the company is not under the jurisdiction of the Commission, a waiver of the sixty-day notice rule (4 CSR 240-4.020(2)(B)), and, if necessary, cancelation of its tariffs.

The Commission issued notice of the application, set a date for intervention of proper parties, and directed its Staff to file a recommendation or status report indicating when it expected to file a recommendation. Staff responded that it intends to file its recommendation no later than August 7, 2019. No intervention requests were received.

The Commission will set the date for Staff’s recommendation as requested and also set a deadline for any responses to that recommendation.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file a recommendation regarding 188 North Summit, LLC's application no later than August 7, 2019.
2. Any responses to Staff's recommendation shall be filed no later than August 19, 2019.
3. This order shall be effective when issued.
