NOTICE REGARDING 2018 RES COMPLIANCE REPORT AND 2019 COMPLIANCE PLAN

On April 15, 2019, The Union Electric Company d/b/a Ameren Missouri filed its Renewable Energy Standard Compliance Report for 2018 and Plan for 2019, as it was required to do by Commission Rule 4 CSR 240-20.100(8). The Commission's rule requires the Staff of the Commission to review the utility's compliance report and plan and to file a report about its review within 45 days. Staff filed a report on the 2018 Report and 2019 Plan on May 30, 2019. Staff reported no deficiencies.

The Commission's rule also allows Public Counsel and other interested persons or entities to file comments regarding Ameren Missouri's Plan.² No comments were filed.

The Commission's regulation does not specify what, if any, action the Commission is to take regarding Ameren Missouri's Report and Plan and any alleged deficiencies in that Report and Plan, except to allow the Commission to direct the utility to provide additional information or to address any concerns or deficiencies identified in the
