**NOTICE THAT CERTAIN TARIFF SHEETS WILL BE ALLOWED TO GO INTO EFFECT, AND ORDER GRANTING EXPEDITED APPROVAL OF TARIFF SHEET**

Issue Date: July 10, 2019

Effective Date July 20, 2019

On June 17, 2019,<sup>1</sup> Union Electric Company d/b/a Ameren Missouri filed a tariff under Tariff Tracking No. YE-2019-0225 to revise its Rider – Economic Development Incentive (Rider EDI) and its Economic Development and Retention Rider (Rider EDRR). That tariff carries a 30-day effective date of July 17. In response to that tariff filing, the Commission directed its Staff to file a recommendation by July 1, and offered any other party an opportunity to file a recommendation or to respond to Staff's recommendation by July 3.

After consulting with the Commission's Staff, Ameren Missouri filed substitute tariff sheets on June 27 to replace some of the sheets it filed on June 17. Those substitute sheets retain their July 17 effective date. At the same time, again after consulting with Staff, Ameren Missouri filed a new tariff sheet under Tariff Tracking No. YE-2019-0231 to modify a related, but previously unmodified tariff sheet. That new tariff sheet was given the

required 30-day effective date of July 27, but Ameren Missouri asks that it be given expedited approval to allow it to take effect at the same time as the other tariff sheets.

Staff filed a recommendation on July 1. No other party filed a recommendation, and no one responded to Staff's recommendation. Staff explains that the revised tariff sheets are intended to make the previously approved Rider Economic Development Incentive (Rider EDI) and Economic Development and Redevelopment Rider (Rider EDRR) more attractive to customers and recommends that the tariff sheets be allowed to take effect on their July 17 effective date. Staff also recommends that the additional tariff sheet filed on June 27 be approved on an expedited basis to be effective as soon as possible.

Based on Staff's unopposed recommendation, the Commission will allow the tariff sheets filed on June 17 (Tariff No. YE-2019-0225) to take effect by operation of law on their July 17, 2019 effective date. The tariff sheets, as substituted, that will take effect are:

Because its order approving the tariff filed on June 27 must be given at least a 10-day effective date,<sup>2</sup> the Commission will approve that tariff to be effective on July 20, 2019, which is the earliest day this order can be effective.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheet filed on June 27, 2019, (Tariff No. YE-2019-0231) is approved to be effective on July 20, 2019. The tariff sheet approved is:
