NOTICE ACKNOWLEDGING DISMISSAL AND CLOSING FILE

Issue Date: July 11, 2019

On April 19, 2019, Union Electric Company d/b/a Ameren Missouri filed an application asking the Commission to cancel the Certificate of Convenience and Necessity granted to Ameren Missouri in 2005 applicable to the property formerly occupied by the aluminum smelter owned by Noranda and now occupied by the aluminum smelter owned by Magnitude 7 Metals, LLC. Ameren Missouri also asked the Commission to cancel its Large Transmission Service (LTS) rate schedule under which Noranda was the only qualifying customer. On July 11, 2019, Ameren Missouri filed a pleading indicating it has voluntarily dismissed its application.

The dismissal of an action before the Commission is controlled by Commission rule 4 CSR 240-2.116(1), which states:

An applicant or complainant may voluntarily dismiss an application or complaint without an order of the commission at any time before prepared testimony has been filed or oral evidence has been offered by filing a notice of dismissal with the commission.

No prepared testimony was filed in this case and no oral evidence has been offered.

The Commission acknowledges the dismissal of this application and will close this file. The procedural conference scheduled for July 24, 2019 is cancelled.
