On July 10, 2019, the Missouri Public Service Commission ("Commission") issued its *Order Granting Certificate of Convenience and Necessity and Waiver* (the "Order"). Missouri-American Water Company (the "Company") had requested a certificate of convenience and necessity ("CCN") to provide sewer service for the Hiller's Creek area described in the Order. The Order, however, granted the Company a CCN to provide water service. The Commission will amend its Order nunc pro tunc to change the word "water" to "sewer" as stated in this Order below:

The COMMISSION ORDERS THAT:

1. The Commission orders that page 7 of the body of the Order shall be corrected and read: "The Commission concludes that the factors for granting a certificate of convenience and necessity to MAWC have been satisfied and that it is in the public interest for MAWC to provide sewer¹ service to the customers currently being served by the Association."

- 2. The Commission orders that page 7 of the body of the Order shall be corrected and read: "Consequently, based on the Commission's independent and impartial review of the verified filings, the Commission will grant MAWC the certificate of convenience and necessity to provide sewer² service within the proposed service area, subject to the conditions described above."

The Commission orders that the second numbered order shall be corrected and read: "Missouri-American Water Company is granted a certificate of convenience and necessity to provide sewer³ service within the authorized service area as more particularly described in Attachments A, B, and C of Staff's Memorandum in support of its Recommendation, subject to the conditions described in the body of this order."
 - 4. This Order shall be effective when issued.
