## ORDER DIRECTING RESPONSE FROM STAFF

On October 13, 2023,<sup>1</sup> Liberty Utilities (Missouri Water) LLC d/b/a Liberty

submitted an application requesting authorization to issue long-term debt in the amount

up to \$30 million.

On December 21, the Staff of the Commission (Staff) filed its Recommendation

which included eight proposed conditions. On January 9, 2024, Liberty responded with

an objection to the sixth condition (condition f in Liberty's motion), which states as follows:

that, to the extent that any non-regulated investments made by the Company or LUCo and affiliated companies may potentially impact the Company's credit quality and resulting credit ratings, the Company shall notify Staff of such possibility and provide a status report to the Commission;

The Commission will direct Staff to respond to Liberty's objection.

### THE COMMISSION ORDERS THAT:

1. No later than January 17, 2024, Staff shall file a response as set forth in the

body of this order.
