ORDER DENYING APPLICATIONS FOR REHEARING

Issue Date: January 10, 2024

Effective Date: January 10, 2024

On November 29, 2023, the Commission issued its *Report and Order* in this matter. That order became effective December 29, 2023. Complainant, Brett Felber, filed a timely application for rehearing on November 29, 2023, and filed an additional/supplemental request for rehearing that same day. On December 13, 2023, Mr. Felber filed a motion to withdraw his rehearing applications. Mr. Felber's motion states that he has no interest in rehearing or appeal of this matter.

Mr. Felber previously indicated that he would not participate in prehearing conferences or the evidentiary hearing, but later appeared at both proceedings. The Commission does not want to deprive Mr. Felber of his statutory right to appeal the

Commission's *Report and Order*.¹ Accordingly, the Commission will not grant Mr. Felber's request to withdraw his rehearing application, but will deny his requests for rehearing. If Mr. Felber does not wish to pursue this matter further, he does not need to do anything, but his right to appeal the Commission's order is preserved.

Section 386.500.1, RSMo., states that the Commission shall grant an application for rehearing if "in its judgment sufficient reason therefor be made to appear." In the judgment of the Commission, Mr. Felber's applications for rehearing do not demonstrate sufficient reason to rehear this matter.

THE COMMISSION ORDERS THAT:

1. Mr. Felber's request to withdraw his applications for rehearing is denied.
2. Mr. Felber's applications for rehearing are denied.
3. This order shall be effective when issued.
