**ORDER DIRECTING AMEREN MISSOURI TO COMPLY WITH THE  
COMMISSIONS RULES CONCERNING CONFIDENTIAL INFORMATION**

On December 11, 2023, the Office of the Public Counsel (Public Counsel) filed a motion requesting the Commission order Union Electric Company d/b/a Ameren Missouri to publicly disclose certain information in its securitization application that Ameren Missouri had designated confidential and authorize Public Counsel to publicly disclose that information. Alternatively, Public Counsel asks that the Commission order Ameren Missouri to fully comply with Commission rule 20 CSR 4240-2.135(2)(B), concerning how confidential information is filed with the Commission.

Public Counsel asserts that Ameren Missouri has not complied with Commission rule 20 CSR 4240-2.135(2)(B) because it has not described how portions of five witnesses' prefiled direct testimony qualify as confidential under Commission Rule 20 CSR 4240-2.135(2)(A). On December 21, 2023, Ameren Missouri filed a response to Public Counsel's motion. Ameren Missouri states that it generally agrees that it failed to fully comply with the designation requirements of the Commission's Confidentiality Rule.

Ameren Missouri agrees that it should be ordered to comply with the Commission's rules, but does not believe there is authority for Public Counsel to publicly disclose information. However, Ameren Missouri's response addressed only the confidential information in witness Steven Whitworth's testimony and attached schedules.

On December 28, 2023, Public Counsel filed a reply to Ameren Missouri's response noting that it was not just the prefiled testimony and schedules from Steven Whitworth that was deficiently described, but also four other Ameren Missouri witnesses. On January 2, 2024, Ameren Missouri responded to Public Counsel's reply. Ameren Missouri asked that Public Counsel's motion to publicly disclose information be denied, but that it be ordered to correct the deficiently filed testimony and schedules.

The Commission will order Ameren Missouri to cure its deficiently filed testimony and schedules.

**THE COMMISSION ORDERS THAT:**

1. Public Counsel's request to publicly disclose information designated as confidential is denied.
2. No later than January 20, 2024, Ameren Missouri shall file amended confidential and public versions of all of its deficiently filed testimony and attached schedules sufficient to satisfy the requirements of Commission rule 20 CSR 4240-2.135(2)(B).
3. This order shall be effective when issued.
